Mayor Elu officially opened the meeting at 10:00 AM in the Bamaga Council Chambers

Agenda Item 2 - 10:000am - 10:45am Minutes of previous meeting of 1st September 2009

 CEO - informed Council that October's ordinary meeting was originally scheduled for the Umagico office but was transferred to Bamaga to coincide with the opening of the Prep school at the Bamaga Campus.

The CEO also highlighted the changes to the previous minutes as requested by the Councillors: -

- o Cr. Bond Dot-point 3 on page 8 of the minutes, change Cr Nona to Cr. Bond
- o Cr. Nona Item 8 in word table / Page 18 (General Business), change Cr. Nona to Cr. Williams

Recommendation: – That Council resolved that the minutes of the previous NPARC Meeting held on the 1st September 2009 be accepted as true and correct.

Matters arising from the previous meeting minutes.

Cr. Lui – Cr. Lui raised the issue of continual correspondence being received from Bamaga Enterprises Limited (BEL) and why were the Councillors for divisions other than Bamaga receiving this material.

CEO informed council that there is an issue with the approach that was taken between Bamaga Island Council and Bamaga Enterprises Limited (BEL) for BEL Enterprise property leasing arrangements. This relates to the "less than market value" charges applied through the lease agreements made by the former Bamaga Island Council, this decision to lease the properties at rates lower than the cost of the "outgoings" of the landlord (NPARC) places the NPARC in a position of financially supporting BEL but without any control over executive decisions. Enmark Businesses Advisors is reviewing the full divestment commitment made to BEL and what this means to the NPARC, the report is due by mid November 2009.

Cr Lui –the process needs to be made clear to BEL to prevent the continuous stream of correspondence being sent by the General Manger.

Mayor Elu – Commented that the Enterprise Divestment issues to be resolved are complex, for example duel resolutions exist for approved use of the vacant block next to the bakery. The first resolution for the vacant block was made by Bamaga Island Council in favour of Mr. K Lui to lease the land for domestic housing, and a second resolution (at a later date)

was made by BIC in favour of BEL for use to establish a commercial interest (shop fronts). The first resolution is current and has never been repealed.

Additionally the NPARC has resolved to adopt an Asset Divestment Policy which must be adhered too; and the Policy includes the establishment of a land leasing policy which must address land tenure issues.

 Council requested the CEO to write to BEL and instruct them to address all correspondence to the CEO only

The CEO commented that he had received copies of all the correspondence and various emails from BEL but had not responded; as the matters are not new and Council had not changed its position on how Enterprise Divestment would be dealt with. BEL is aware that Enmark Business Advisors were acting as Councils agent in these matters.

<u>Endorsement of the Funeral Leave Policy - The CEO presented a draft Bereavement Policy</u> for comment / endorsement

CEO - Advised council that many employees are using the excuse of funerals / "sad business" to take extended leave. Council is experiencing multiple employees taking two to three weeks bereavement leave and it is very difficult for the director to manage; as there is currently no requirement for employees to provide evidence of direct family ties to the deceased person. Additionally, there is strong evidence that the employees are also holding their children at home and they are not attending school. The CEO also reported to Council that is difficult for non-Indigenous administrator to draft policy on these matters when we do not fully understand the local culture.

Cr. Lui - what about consideration for the large role that In-Laws (marigeth) play in supporting the bereaved family?

Mayor Elu - commented employees taking extended funeral leave are creating a major operational problem by leaving council with no workers to cover the period of absence.

Council requested a cover note be added to the Bereavement Policy to advise that: - For extended family members the leave (if approved) is unpaid; and leave must not affect operational performance

Main Roads officers assisting with various matters in NPARC, initially working on the Seisia Jetty project **Bruce Mitchell** and **Rex Beer.**

Main Roads – Working with council to review operational issues with the Seisia Wharf and Boat Ramp.

Ken Mc Andrew – Main roads, the Seisia Jetty was build in 1993 – ownership transferred from Main Roads to Queensland Transport (QT). We have not collected fees from passengers or vessels for a long-time. The current way of is not working and the jetty is falling into disrepair due to vandalism and Ship Strikes.

Options are

- 1. Locally owned and operated, or
- 2. State owned & operated

Initial thoughts are to have the facility locally managed thru a local manager (from NPARC employees) – the role would be to collect money and manage jetty functions. The funds would help for wages and any surplus would go to QT for maintenance

Mayor Elu – Land adjacent to the jetty was under special lease to Seisia Island Council, this is the land were the existing shed has been established. Any fees would be passed onto the passengers.

 Queensland Transport will prepare an Options Report to be presented to NPARC December meeting 2009

New Boat Ramp – Maintenance on the Seisia Boat Ramp would include the removal of sand build-up, water blasting (slime build-up) and other repairs by agreement. Maintenance activities to the boat ramps would attract additional annual funding of \$70k. The fees would not fully fund the facility for operation and maintenance. Council may need to consider fees per passenger ship of around (\$16.00 per ship) per docking.

Colin Neville – We are currently looking at a mentoring program that would see Ex-school students (professionals) to visit the NPA as mentors to the current school students. LIPA 12 months ago we began the process to collect the relevant data from the key agencies, communities and from community forums. The format changed recently to the commonwealth format, this is the first LIPA is this format in Queensland, I have five copies that we are hoping to sign today and they will go to the Commonwealth and the NPARC Government Champions for signing. We are looking at the next round of Public Consultation in September 2010.

CEO - Commented that the Council Annual Reports should become attachments to the LIPA

Mayor Elu – the 2007 Ministerial review of Sport and Recreation was not released to Council for comment. Seisia Council did write to Minister Spence saying that Council did not agree with the States intention to move S&R funding to the PCYC organisation. The Initial MOU from Cape PCYC was a very poor document and gave the NPARC no confidence in PCYCV as an organisation.

- What about events, will PCYC undertake these activities

It was decided that Cape PCYC will work through the Director of Community Services and develop an annual calendar of events and an operations plan for the two agencies.

Serilli Vola Vola - well continue working for Council as the events coordinator

Cr Lui - Sport and Recreation (Department) failed, what difference will PCYC make?

• Peter Pilot – We do not underestimate that this will be a major challenge in the first year

Cr Bond - Council needs to be fully informed of any dissection of current activities in the NPA
