## Agenda Item 1 - 9:00am to 9:15am Minutes of previous meeting of October 2009

- CEO Mentioned the report from Queensland Transport on Marine Facilities had not been received and would be chased-up for the December meeting.

#### **Matters Arising**

## Reg Williams joined the meeting 10:00AM

#### Letter - Housing - 40 year leases

**Cr. Elu –** Council should withhold making a decision until after the November Ministerial meeting in Cairns, as the Housing issues will be a strong subject for debate.

**Cr. Bond** – Does this also now make a situation for outsiders to come-in and take control of community housing?

**Cr. Elu –** These are questions for the Minister at the round table discussions.

• Council reviewed and endorsed the NPA News Letter No 7

**CEO -** 'Blue Light Disco, Injinoo" The CEO commented on the blue light disco held in Injinoo on Friday night; which attracted 200 children. The event was promoted and coordinated by the State Police, Bamaga with assistance from school teachers, Community Police and the Cape PCYC.

CEO -"I was overwhelmed by the positive reaction of the children and the obvious benefit these types of events provide to the communities youth". The 'personnel effort' of the Bamaga Police Officers is to be commended.

During the night the children had to access water from external taps, and I recommend that Council provide a donation of \$500.00 to the Blue Light Disco (NPA) for the purchase of water coolers, disposable cups and other minor items.

**Cr. Nona** – Commented that "I went and had a look at the Disco and was very pleased to see so many children enjoying a well-run event".

**Recommendation**: That Council make a donation of \$500.00 to the State Police (Bamaga) for the purpose of purchasing minor items for the Blue Light Disco's being held for the NPA Communities.

<u>Cr. Williams</u> What about appreciation of the workforce in the form of a BBQ and/or ask the contractors to make a donation for a Christmas party

**Cr. Elu** – We need to get a social club going for the employees to support their own Christmas social function and other function they regard as important.

**CEO** – If Council is going to make a budget commitment to the staff for Christmas 'break-up function" we should consider a dollar (\$) amount per employee of \$10 dollars per head, this would be total commitment of approximately \$3,300.00

Council supports the NPARC providing a BBQ / afternoon tea for the employees as a Christmas break at a funded level of \$10.00 per employee.

Council – Discussed the issue of holding 1 x Council meeting per year in Cairns to take the opportunity to meet with senior officers of government agencies. <u>Council endorsed</u> a meeting to be held in Cairns on December the  $8^{th}$  and  $9^{th}$  to provide an opportunity for stakeholders to discuss any issues with the full Council and for the Council to request individuals to address the Council on a range of issues.

<u>CEO - The CEO commented on the January meeting and advised council that the current endorsement by council to hold a meeting on the first Tuesday of each month will see the 2010 January meeting being held during the Christmas and New Year break.</u>

# Agenda Item 3 - 11:45am to 12:30pm Director of Engineering Report (to follow Finance Report)

**Cr. Williams**\_The workshop bitumen seal needs to be increased to the whole Umagico Engineering compound as dust is still blowing into the welding shop and the surrounding houses. - CEO to chase up with the Director of Engineering Services

**Cr. Elu** - we also need to seal the Seisia Boat ramp area and storage shed area.

**Cr. Williams** – questioned the process for the airport fencing and the cost of the concrete, why can't the council supply the concrete which would reduce the tender price and the revised tenders may come within budget. – *CEO to discuss with the Director of Engineering Services* 

Cr. Nona - Why are the parks looking so dry and a state of terrible disrepair?

**CEO** – We need to investigate options for the parks to ensure we construct appropriate structures and install drought proof plants. The issue of not having a water allocation is a major factor in the current poor health of the grounds.

**Cr. Williams** – I am going try and establish a community committee to revive the Lui street Park. Council needs to re-test the existing bores (at Bamaga nursery, near Mudu St. and the Lui St. Park.)

**Cr. Bond** – commented on the New Mapoon All Disability Playground (re: high ongoing cost) – we did consider and incorporate the use of drought resistant plants and sustainable play equipment.

**Cr. Elu** – As the infrastructure comes due for major up-grades we need to apply for Special Purpose funding to assist with Asset Renewals.

### Agenda Item 4 – 9:45am to 10:00am Finance Report (bought forward 11:00 AM)

Peter Andersen - As per written report

**Mention** –Umagico, it has taken a long-time to get the 2007 – 08 Financial Statement work through to the QAO, the statements are with the QAO and they have come back with only one query which is "was there any indication of a Budget for Umagico in the 2007 / 2008 year"

**Cr. Elu** – Why is the Bamaga 2007 – 2007 Qualified Audit still being reported to Council, does the qualification affect the NPARC 2009 Audit.

**Peter Andersen** – The 2006/07 is not our (NPARC) responsibility but qualifications are carried and must be resolved. QAO Auditors are currently in the Cairns office and will travel to the NPA next Monday for three days and then back to Cairns on the 13<sup>th</sup> November for the Exit interview with the Mayor and CEO.

Cr Nona – was concerned on several occasions where pays has been late. Peter Anderson commented that payroll has been extremely busy with the amount of amendments and back pay being process, and supervisors presenting timesheets late was a major concern for the payroll officers.

**Cr. Lui** – Can we re-investigate the issue of getting paid weekly? – *Peter Anderson to follow-up.* 

**Peter Anderson** – announced the recruitment of Annette King as the new NPARC Grants Officer (Cairns)

**Cr. Bond** – Is it possible to have the NPARC Grants Officer assist community forums and / or enterprises to gain grant funding.

**Cr. Elu** – Alex Barker will continue to assist with his issue, we also need to a establish a contact with the Department of Economic Development

**CEO** - Cautioned Council on distracting the Grants Officer from concentrating on NPARC grants as there are a large number of existing grants to reconcile and manage, and coordinate new grant applications.

<u>Cr. Nona – The manager of the Service Station was not operating the enterprise according to 'full' trading hours and that he was in need of support from Council to consider training and providing extra staff. I am getting reports from the community that we need to improve the variety of stock held at the Injinoo Service Station, in particular, essential items for the community members who lack mobility and cannot get the other community stores.</u>

CEO – I will chase investigate this issue with the Director of Enterprises; we also need to get a building quote to "block-in" the back veranda to create additional covered storage area.

Cr. Williams – Will the Jardine Ferry operators begin staying in the house or are they going to travel each day. – *To be investigated by the Director of Enterprises*.

By the time the repairs are being addressed additional faults are occurring as a result of the original issue <u>not</u> being dealt with. It appears that 'good rent payers' are not being serviced for genuine complaints? – *Issue to be raised with Engineering Services to investigate opportunities for a senior person from the Department of Housing or Q Build (Toni Malamoo) to meet with Council in Cairns at the December Meeting.* 

**Cr. Bond -** The Road is being graded from the Main Road to Loyalty Beach, so why it is not graded to Blue Valley - *Question for Engineering Services* 

**Cr. Bond** – The old camps, can they be cleaned up along the coast from Loyalty Beach to Patterson Creek – *Engineering Services to investigate* 

**Cr. Lui** - Old BRACS Building Umagico - Council has an opportunity to lease the old BRACS Building. - *Engineering Services to indentify a lease amount for Preston Law to include in the development of a lease agreement.*
